With reference to your D.O. letter No.12/4/2016-TS.V dated 12th September, 2016 on the parity of Two Year Full Time Postgraduate Diploma in Management offered by the new IIMs with Master's Degree of an Indian University for the purpose of admission to Higher Studies.

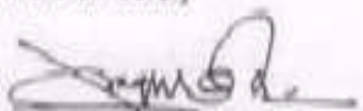
The matter was placed before the Equivalence Committee at its Meeting held on 5th January, 2017 and also in the 341st Meeting of the Governing Council held on 9th January, 2017 in AIU House, New Delhi.

The Committee resolved as under:

"The Members considered the proposal and decided that since the IIMs are premier Institutions under the MHRD, the Two Year full time Postgraduate Diploma in Management awarded by the Indian Institutes of Management be accorded equivalence with Master's Degree of an Indian University for the purpose of admission to higher studies. The condition of AICTE approval and NBA Accreditation for the programme shall not be applicable in case of IIMs".
